# ATT EXAM STRUCTURE

This is a modular structure offering a choice from six free-standing Certificates of Competency so if a candidate works wholly in, for example, personal tax compliance, they will be able to take an examination in that topic only. This will lead to the award of a Certificate of Competency in personal taxation. For full membership three papers must be passed together with the two E-Assessments and two years' practical experience in UK taxation.

- Valid for three years
- No requirement for practical UK tax experience
- Renewable on submission of CPD record and payment of a fee


