As an ATT examination candidate you are strongly recommended to follow a properly structured course of study designed specifically to prepare candidates for The Association of Taxation Technicians' examination.

The list that follows is compiled from information provided by the organisations listed. The Association of Taxation Technicians does not control or supervise any of these courses and is in no way responsible for their content or conduct.

When deciding upon your course provider, we recommend that you ask questions concerning the qualifications and expertise of the lecturers, the number of students on the course, the number sitting the examination and examination pass rates.

Failure in the examinations is very often clearly due to a lack of preparation, especially insufficient practice at answering questions. You are urged to do as much written work in your preparation as possible.

Most candidates would benefit from following a distance learning course AND attending evening classes and/or intensive revision courses.

Colleges cannot afford to run courses unless enough students enrol BEFORE the commencement date for the course. This is particularly important for Local Authority Controlled Colleges running evening classes.

DO NOT WAIT UNTIL THE BEGINNING OF TERM TO ENROL: IT IS NEVER TOO EARLY TO START YOUR PREPARATION.

The Association would like to remind all students who wish to take the ATT examinations at least six months before they wish to sit the examination.

You should not expect the tutorial bodies to be responsible for your registration with the Association or for your examination entry.
